- Vendors may not use their own tables to display products for sale.
- Display of any additional objects/equipment, such as tents and panels, require prior authorization from the Organizing Committee. **Tent colors must be dark blue, yellow, green or white** (colors of the Brazilian flag).
- Vendors may not arrive before 10:30 a.m. on the day of the festival.
- Vendors may only sell from the location of their table.
- Parking directly in front of the Festival entrance is TEMPORARY. After unloading vendors must remove their vehicle.
